## ROUTINE SPECIFICS

- All teams must have at least 3 members.
- Performance time limit is 3:30 minutes. Time will begin with the first movement or word by a team member, or the first note of music. Time will end after the last motion of the routine is held for two seconds. Squads should quickly exit off the mat upon completion of routine. There will be a 1- point deduction for each second over the 3:30 minute time limit.
- Each team must perform at least one chant/cheer and one dance, in any order.
- Signs, poms, flags and megaphones are the only props permitted. Use of any other prop is prohibited (includes hats, gloves, pieces of material, etc.) Mini-tramps and springboards are prohibited. Teams using prohibited items will be disqualified from the event.
- Routine choreography and music selection must be suitable for family viewing. Inappropriate choreography will result in a 30-point deduction.
- RULES AND REGULATIONS:
  - The coach or coach appointed representative will be responsible for running their music during the competition. A sound system with CD player will be provided. Please bring two quality CDs of your music. Some custom-made CDs may not play on some systems, and we will not be responsible for technical problems with your CD's. In the event your routine is interrupted because of failure of our equipment, facilities, etc., or in the case of a severe injury and your routine needs to completely stop, you will be permitted to restart your routine from where you stopped. If an interruption occurs due to your coach or appointed representative or CD, your team must continue with their performance with time running or withdraw from the competition. **AUX cord will also be provided.**
  - Each team must be accompanied by a coach or adult 18 years or older. Only two coaches per squad will be admitted into the competition free of charge.
  - **ABSOLUTELY NO LOOSE GLITTER - INCLUDES SPRAY-ON GLITTER! GLITTER IN HAIR, ON FACE, ON UNIFORMS OR ON SIGNS IS PROHIBITED DUE TO ISSUES WITH CLEAN-UP. TEAMS USING GLITTER IN ANY WAY WILL BE IMMEDIATELY DISQUALIFIED FROM THE EVENT.**

- No jewelry of any type is allowed. Tattoos must be covered. A 10-point deduction per member not following rules will be assessed.
- All participants must have a signed Waiver Form completed and turned in by the end of Team Registrations the day of the event in order to compete. All coaches should have Emergency Information Sheets for all squad members with them the day of the competition in case of accidents or emergencies.
- All teams competing must have a signed Terms of Agreement and Music Copyright Certification Form completed and turned in by the end of Team Registrations the day of the event for the team to compete. Teams must agree to comply with the directives outlined in the Music Copyright Education Initiative promoted by the USA Federation for Sport Cheering [https:// www.usacheer.org/presssafety/music](https://www.usacheer.org/presssafety/music) and that proper permissions were obtained regarding their team's use of music.
- You will receive a confirmation packet by email after the registration deadline, including scheduled warm-up times. Please be sure to include an email address on your registration form. If you do not have an email address, please include a mailing address.
- Performance area will be a 42' x 54' Cheer Mat (9 cheer mats). There will be not out of bounds. However, we suggest all tumbling be performed on the mat for safety reasons.
- Scheduled warm-ups will be held on performance mats prior to competition. All squads will be issued a 5 min warm-up time. If you miss your scheduled warm-up time, unfortunately, you will not get mat time.
- A Concession Stand will be open during the event.
- Judges will be scoring the competition on a 100-point system per judge. In the event of a tie, the squad with the highest overall performance scores will be declared the winner. All judging and rule interpretations are final.
- The Ottoville Competition organizers reserve the right to add, change, delete, split or combine divisions.
